<u>Directors' & Officers' (D&O) Liability Insurance</u> – Material from HOA Leader dated June 2008 with no new updates, on this subject was passed out to members, along with reasons to carry this insurance, and the current quote of coverage (four pages total). The First article was "HOA Board Members: Ensure that You're Personally Insured". A comparison of the POA Liability insurance vs Board member coverage. One member stated: "don't need we are incorporated? Another stated: Current insurance is inadequate; each board member needs own coverage". Note: Our current cover is for "one-year extended reporting of past claims occurring during the 3-year coverage period, Oct. 2020- Oct. 2023. recommended by the current provider when we opted not to renew the D&O Liability Insurance, Past reasons for not renewing - incorporated-non-profit-with no employees, Bylaws Article X, paragraph 2 "The private property of the directors and the membership of the Association shall be forever exempt from the Association's debts and obligations." also covers the ACC as a community volunteer committee under the HGEPOA Board of Directors.
