**High Gabriel Water Supply Corporation - Annual Meeting 7 February 2026**

Well #1: when operating ~30 gal/min,  
pump is 590 feet from surface in Trinity Aquifer  
continues to be off-line due to low water levels


Well #2: not operational (several years),  
*considering refurbishment in 2026*

Well #3: ~100-130 gal/min,  
pump is 650 feet from surface in Trinity Aquifer  
main water source – major repair completed early 2025

Brazos Water Authority: contract for 310 acre-ft/year water  
(water not supplied)

*Tiered rate structure: costs ~same, income ~same due to conservation*



## HGWSC 2025 Major Accomplishments (Jan 2025-Jan 2026)

1. New Water Operator: Cliff Farmer with Texas Water
2. Tarriff written & recorded with PUC; tiered water rates in effect
3. HGWSC By-Laws amended & on website
4. 11 Line Repairs
5. Well #3 refurbished & operating at near capacity

1. Back-up Water Source: refurbishment of Well #2
2. Automate System (SCADA controls)
3. Financial data organized in QuickBooks
4. Testing to assess viability of Well #2
5. HGWSC became member of Texas Rural Water Association
