Regular Monthly Meeting Minutes: 12 January 2026
At First Baptist Church, Leander TX**

Meeting called to order by Denny Springer at 6:31 pm

Attendance: Scott Childress, Ben Marquardt, Don Mohler, Denny Springer, Aleta Wilder, Jeremy Wise
Danny Roberts (absent)

- Approval of 8 December 2025 minutes was tabled.

System Report: Cliff provided summary update.

- Flow Test was completed for Well #2 and a data table was provided. Flow Test Report has not been received.
- Description and estimate for control panel repair has not been received.
- No line repairs during December although small leak at corner near pump station, to be fixed soon.
- Cause of higher loss is unknown; possibly due to use from fire hydrants or leakage from known small leak.

Treasurer's Report: Accepted as is.

- Positive balance this last month.
- Ben has established a general ledger in QuickBooks for accounting.
- Ben has verified that HGWSC liability insurance has been paid.

Well #2 Flow Test: Denny discussed draw-down table provided by Advanced Water Well Technologies.

- Pumping started at 40 gal/min then after 20 minutes decreased to 28 gal/min, maintained for 1 hour.
Water level went down, then up: suggesting that the well "recovered".
No water samples were taken, but the water was visibly clear.
- Cost to bring Well #2 on-line will go out for bid; new cable, transformer, & instrumentation may be needed.

Issues regarding Signal Hill: No representative from Signal Hill development were present at meeting.

- Board Members voiced concerns regarding heavy equipment using the easement road to access Signal Hill and the need to protect the water main under the road.
- Legal advice has not yet been found to respond to questions from representative of Signal Hill developers.
- Ben recommended membership in the Texas Rural Water Association (TWRA) to access legal guidance.
- Aleta made motion that HGWSC apply for TRWA membership for 2026 at a cost up to \$500;
Scott 2nd, passed 5-0-1.

Website, emails, & PO Box:

- General agreement that HGWSC website needs improvement. Scott suggested that Member Amy Day could help with website. HGWSC may need to have its own PO Box separate from POA.
- Aleta made motion to give Ted a gratuity of \$150 for his work with the website; Don 2nd, passed 6-0-0.
- Board Officer positions will be assigned an email address through the website provider.
- Ben & Aleta will check records to determine what chairs each Board Member holds & the chair election year.
Denny announced he will not be running for a Board position this year. Aleta left the meeting at 8:20 pm.
- Board discussed D&O insurance and will reach out to vendors to get quotes and specifics of what coverage entails.

Motion to adjourn the meeting at 8:30 pm was made by Denny, Ben 2nd, motion passed with a vote 5-0-0.
