#### **Secretary's Report:**

a. Board Vacancies: Interest has been shown by several members to the request for new Board Members but no one has actually volunteered for a position/seat.

Note: Unanimous voting is still required due to lack of having a chairman, as is establishing a Pro Temp at the beginning of each meeting.

- b. Support & Guidance Material: Virginia handed out copies of The Complete Idiot's Guide to Robert's Rules which she had purchased from The Thrift Shop on the internet six copies were bought.
- c. Directors & Officers' Insurance: After much research and comparison, we now have a policy for this coming year for \$1,600 with a \$1,000 deductible if a claim is made.
