

**High Gabriel Water Supply Corporation
Regular Monthly Meeting Minutes: 13 July 2026
At North Way Bible Church, Leander TX**



Meeting called to order by Don Mohler at 6:02 pm.

Attendance: Scott Childress, Jon Legalos, Ben Marquardt, Don Mohler, Aleta Wilder, Jereme Wise
Absent: Danny Roberts; Members: Monica Burrage (POA Secretary) and Luther (of North Hill)

- Monica indicated that Jeff Brooks is owner of the Signal Hill venue property. Monica addressed the Board regarding contacting the Fire Marshall. The questions posed include: (i.) realignment of pvr 949; (ii.) liability due to pvr949 crossing HGWSC property; and (iii.) water well & sewage treatment permitting.

System Report: Cliff provided summary update.

- Well #3 pumping 141 gal/min, working well.
- No activity with Well #1. Don asked to have Well #1 turned on. Cliff said Well #1 could be used after it is flushed.
- The aquifers appear to be flowing well.

Treasurer's Report: Accepted as is.

- Automatic payments to Texas Water and contract for system operation are now in place.
- Don made a motion to pay \$795 invoice for leak repair near 1200 S. Gabriel, Ben 2nd, motion passed 6-0-0.

Other Business:

- Don gave review of HGWSC progress during 2026 for Jon and Jereme.
- Don would like HGWSC to apply for grants &/or loans from the Texas Water Development Board (TWDB). The deadline for proposals is 31 July 2026 (2 weeks). The nonprofit companies available to help with proposals have not responded to phone calls. Don suggested that a financial audit and engineering review by TWDB would be required with any accepted proposal. No one volunteered to prepare proposals for this year.
- Don asked Aleta to change the address on the HGWSC Tariff from 100 Skyview Terrace to 104 Skyview Terrace.
- Don described desired changes to the draft 8 June 2026 minutes. Aleta explained why she could not make all of the requested changes. Don made a motion to table the 8 June 2026 minutes, Ben 2nd, and the motion passed 4-1-1 (Don dissented and Jereme abstained).
- Don said that a second secretary was needed for signature at Chase Bank accounts. Don made a motion to nominate Ben as Treasurer & Assistant Secretary, Scott 2nd, motion passed 6-0-0.
- Motion to adjourn the meeting at 7:28 pm was made by Don, Scott 2nd, motion passed with a vote 6-0-0.
